P20-001 Oncenter Construction represented by Thomas Duch Esq 550 Mola Boulevard Questions arose and were addressed pertaining to lot sizes, driveway entrances and exits, safety issues, no parking on River Road, flooding, NJDOT approval, easement being included as part of lot size, police traffic study, one family homes, no crossover of lots, radius of driveways, exploring increase of openings and moving to the right.

Applicant engineer will speak with the planning board engineer.

P20-002 Marcal Manufacturing, LLC represented by Thomas Duch Esq 550 Mola Boulevard Seeking approval to store finished product in 240 trailers.

Trailers will be located on existing pad.

Currently using 175 trailers for storage.

Once new build is built plan is to stop storage use in trailers. Within 180 days of completion of new building trailers would not be needed.

90 feet distance between each row of trailers.

No proposed lighting changes.

Distribution manager express they would be exiting warehouse at 35 Market and in need of trailer storage during transition until building is built on north side.

Meeting was held prior to tonight about work to be done on fire hydrants.

Members expressed concern, what are the plans for the area after warehouse is built and what if any additional traffic will there be.

P20-003 Marcal Manufacturing, LLC represented by Thomas Duch Esq 550 Mola Boulevard Seeking development of metal building.

Construction of one-story metal building 29 feet 5 inches tall, metal skin, concrete slab, prefab building, 8 loading doors to the north center row columns.

There is no existing drain run off at the site. Everything is pitched to the north.

Building will employee 6 at one time.

No plan for any rest room.

Member concern, sprinkler system if only electric in building, how many trailers will be on site, one exit and entrance on River Drive, no access to back of building, footing or piling required?
