## TOPOLOGY PRESENTATION:

CHRISTOPHER COLLEY, Topology, 60 Union Street, Newark, New Jersey, sworn.

The Chairman noted for the record the Council has already approved the Resolution.

Mr. Colley testified he is a development analyst with Topology. He placed his qualifications on the record. He testified he has previously met with the

Council, and is before this Board to talk about the rehabilitation area.

Mr. Colley reviewed the area in need of rehabilitation and reviewed the process that will follow and will welcome any recommendations the Board has to send to the governing body.

Mr. Colley reviewed studies that have been performed of the areas in question. He testified a rehab designation, in itself, does not change any Zoning regulations.

Mr. Colley reviewed the photographs presented to the Board.

GREER PATRAS, Planner, Topology, 60 Street, Newark, New Jersey, sworn.

Ms. Patras testified this is setting the stage for anything to be built more easily on top of a rehabilitation area. She testified this would lay the groundwork for a five-year tax abatement, but same is not automatic.

She testified nothing is happening in terms of development, as there are still eight to twelve steps.

After further discussion and questioning by the Board, the Board suggested Mr. Colley produce documentation exhibiting other work that Topology has performed, and Mr. Colley agreed to submit same.
