# Findings 2022, 1,2,3,4,5

- Capital Fund Improvement Authorizations greater than five years old have unfunded portions outstanding.
  - 2. Outside Duty/Outside employment of borough police officers are not being accounted for in accordance with Local finance Notice 2000-14.
  - 3. Cash receipts/revenues, other than tax collections, are not being recorded through the Borough's accounting software, but rather being compiled manually through the use of an excel spreadsheet.
  - 4. An error during the calculation of an employee's base pay resulted in that employee being overpaid for the calendar year 2022.

# **Explanation and Corrective Action**

- 1. CFO to review greater than five years old unfunded bond ordinances be cancelled via resolution.
- Police Department shall keep detailed log and ledgers indication the billing to vendors as well as receipts to be posted to that generated invoice within the Police Department.
- 3. Cash receipts shall be integrated within the Borough's software system.
- 4. CFO to ensure base pay calculations are to Borough ordinances, contracts.
