**BUILDING UPDATE**

## **PUBLIC COMMENTS**

Jeff Freitag (35 Hillman Drive) had a question regarding the status of approval by the Building Department and whether it had gone that far. Doris Wechtler informed him she hadn't heard anything yet. Kathleen Policano mentioned we hadn't been updated as to the statues since the change order was passed at the previous meeting, but that the architect would have gotten right to work after receiving our approval. Kevin Neary mentioned he had heard from the contractor that they had received a question from the Building Department; he assumed it had been a clarification type question, so he also assumed that must mean the Building Department had received and was reviewing the drawings. Kathleen Policano also mentioned she heard when she had stopped by earlier that day that the Head Contractor would be there the next day, so she intends to see him and get some clarification. Doris Wechtler mention when she had last asked Mayor Colletti about an update, last Thursday, he had said he should be updated by Monday night, but she thought that the death in his family would have made an update unlikely to have taken place. Kathy reiterated that she would be going over the next day and would report back to the Board with anything she found out.

Jeff Freitag also asked who do they report too, and how are progress reports given? Kathleen Policano replied that they go to the Architect in charge or our building, and he would report to the Board President, but she had not heard any update at that time. Jeff Freitag and Doris Wechtler discussed meeting attendance at Board Meetings. Jeff Freitag also expressed concern over the coming cold weather and what that would mean for paving and asphaltting. Geraldine Mola requested that the Board be notified with an update from what is found out at tomorrow's meeting and Kathleen Policano agreed.
