## BOROUGH OF ELMWOOD PARK WORK MEETING October 3, 2019 7:00PM

The Work Meeting of the Elmwood Park Mayor and Council for October 3, 2019 was called to order by Acting Municipal Clerk Erin Delaney at 7:03PM. The Statement of Compliance was read.

Councilmembers Balistrieri, Fasolo, Wechtler, and Council President Pellegrine were present. Also present were Mayor Golabek, Acting Municipal Clerk Erin Delaney, Borough Administrator Michael Foligno and Borough Attorney Salvatore A. Ingraffia.

Jeffrey Freitag, Hillman Drive, asked if the Market Street and Mola Boulevard Army Tank area would be sodded.

- a. Fair Lawn Ordinance No discussion ensued.
- **b. PEG Channel Cost** Acting Municipal Clerk Delaney reported out on the cost of the Borough obtaining its own PEG channel as per the request of Councilman Dombrowski at a September work session meeting. The Governing Body concluded that the Borough's current status is sufficient without having to attain a private channel.

The Mayor and Council were in favor of the purchase but requested that Mr. Karcz make a formal request at the October 10<sup>th</sup> work session meeting. Further discussion ensued where the Governing Body agreed that any purchasing request over \$17,500.00 should warrant an in-person proposal at a work session meeting by all Department Heads.

## **6 – APPLICATIONS:**

**a.** Liquor License, Person-Person & Place-Place Transfer – Acting Municipal Clerk Delaney, in addition to Borough Attorney Ingraffia, reviewed details of the application with the Mayor and Council. They highlighted that the proposed location is within a certain proximity to a learning facility and another business holding a liquor license. Ms. Delaney further explained that although the license is a distribution license, the business does not intend to sell alcohol on-site but rather as a packaged basket company that ships items off-site. The Mayor and Council agreed to move forward with placing the transfer application on the agenda for the October 24<sup>th</sup>, 2019 with potential special conditions to be discussed.

## <u>7 – COMMITTEE REPOR</u>TS:

Councilman Fasolo shared the following upcoming events during his Board of Education report: Coach Abramo dedication game, Mallory's Army, Class of 2020 fundraiser, and the next Board of Education meeting. He then announced that he recently representing the Mayor and Council at the Anytime Fitness Grand Opening. The end his report, Councilman Fasolo raised a concern regarding the traffic lights near Market Street and River Drive as it is difficult to determine which color the light(s) are on when approaching.

Councilwoman Wechtler updated those in attendance on the Homeowner's "Meet the Candidates" Night and shared upcoming meeting dates for the Homeowner's Association and Library Board.

Council President Pellegrine announced, on behalf of the Board of Health, the October 27<sup>th</sup> date for their Health Fair in addition to the Chamber of Commerce's fundraiser to benefit the RAP Program and Rare is Beautiful on October 26<sup>th</sup>. In regards to her police report, Council President Pellegrine discussed the Street-Smart campaign and Coffee with a Cop event. Lastly, she concluded her remarks by stating the recent Council Corner meeting resulted in a lot of great ideas that both she and Councilwoman Balistrieri will be looking into.

Councilwoman Balistrieri discussed the DPW line painting program and fire hydrant flushing. Moving on to her Recreation report, she announced soccer and basketball registration information and that the Halloween party is scheduled for Wednesday, October 30<sup>th</sup>. Councilwomen Balistrieri suggested that the Borough look into placing a Port-A-John at the Gilbert Avenue field. She ended her committee report by stating the next Elmwood Park Takes Action (Stigma-Free) meeting is set for October 16<sup>th</sup>.

Carl Roberts, Washington Avenue, stated that chicken coops are currently not allowed within the Borough and that the reason for the lack of a Port-A-John at the Gilbert Avenue field is because the old one caught fire.

Jeanne Freitag, Hillman Drive, inquired further about approving a liquor license with special conditions. Additionally, she asked for more information on the process of when a ticket is written when a vehicle is parked too close to a stop sign.
