**WHEREAS,** the Mayor and Council of the Borough of Elmwood Park have been and are aware of multiple complaints from the residents regarding large size vehicles parked in residential zones, and utilizing the residential driveways in the residential zones; and

**WHEREAS**, the Mayor and Council has determined that there is a need to limit and or prohibit such utilization of driveways in residential zones; and

**WHEREAS**, the Mayor and Council has determined that such limitation and or prohibition would advance the health, safety, and welfare of the residents of the Borough of Elmwood Park.

**NOW THEREFORE IT IS HEREBY ORDANED**, by the Mayor and Council of the Borough of Elmwood Park that Chapter III, Article 3-9A, Section 3-9A.1 is hereby amended so as to reflect the following wording:

# Section 3-9A. PARKING OF COMMERCIAL VEHICLES IN RESIDENTIAL AREAS DURING CERTAIN HOURS PROHIBITED.

Section 3-9A.1. Prohibited. [Ord. No. 07-9 § I; Ord. No. 07-14 § I]

a. No person shall park a commercial vehicle, including any vehicle bearing commercial plates, any truck, limousine with OL plates, omnibus, taxi cab, or ambulance, between the hours of 2:00 a.m. and 6:00 a.m., upon any of the streets in the Borough of Elmwood Park.

However, nothing in this section shall prohibit any limousine, taxi cab, ambulance or omnibus from picking up or delivering passengers at any time.

b. No person shall park or cause to be parked any trucks, buses, limousine or vans over the height of 9' (feet) clearance measured to the tallest part of the vehicle and or greater than 22' (feet) in length and or greater than bearing weight of 17,000-pound GVW, on any residential property in the Borough.

**BE IT, FURTHER ORDANED,** by the Council of the Borough of Elmwood Park, that if any provision of this amended Ordinance shall be held invalid, or contrary to the law, then such provision of the Ordinance shall be deemed separable from the remaining provisions of this Ordinance and shall not affect the validity of the other provisions of the Ordinance.

**BE IT, FURTHER ORDANED,** by the Council of the Borough of Elmwood Park, that all other language contained therein shall still be valid and remain in full force and effect.

**WHEREAS**, the Mayor and Council has determined that there is a need to limit and or prohibit and control such parking during prohibited hours; and

**WHEREAS**, the Mayor and Council has determined that such limitation, control and or prohibition would advance the health, safety, and welfare of the residents of the Borough of Elmwood Park.

**NOW THEREFORE IT IS HEREBY ORDANED**, by the Mayor and Council of the Borough of Elmwood Park that Chapter VII, Article 7-15.1is hereby amended so as to reflect the following wording:

A. No person shall park a truck, tractor, trailer, or semi-trailer having registered gross weight in excess of 3 tons (6,000 lbs.) upon any street between the hours specified. Truck, tractor, trailer, or semi-trailer will be permitted to be parked on the street for the limited purpose of making customary pickups and deliveries of materials or goods.

A.1 Proposed Fine Schedule:

Failure to comply with the provisions of this section shall subject the owner of the vehicle to a fine of \$100 for a first violation. For a second violation, the owner of the vehicle shall be subject to a fine of \$200. For a third or subsequent violation, the owner of the vehicle shall be subject to a fine of \$300.

**BE IT, FURTHER ORDANED,** by the Council of the Borough of Elmwood Park, that if any provision of this amended Ordinance shall be held invalid, or contrary to the law, then such provision of the Ordinance shall be deemed separable from the remaining provisions of this Ordinance and shall not affect the validity of the other provisions of the Ordinance.

**WHEREAS**, due to an aggregate 3% increase in water consumption from bulk water supplier, Passaic Valley Water Commission, the following is necessary;

Installation, replacement, and repair of existing meters shall be charged at actual current cost for labor and material incurred by the Water Department of the Borough of Elmwood Park and/or Passaic Valley Water Commission.

F. All commercial users having meters in excess of  $\frac{3}{4}$ " must have them in working order at all times. In the event said meter is inoperative, and no attempt is made for repair/replacement of same, the existing estimated bill shall be tripled the existing estimated rate, upon the effective date of this ordinance. In the event no meter in excess of  $\frac{3}{4}$ " exist, in addition to the tripled estimated bill, the landlord shall be required to purchase and install same upon written order of the Superintendent of Public Works.

Section 4: "In the event that payment for water charges is in arrears for 30 days from date of billing, the Borough shall send a delinquent notice regular mail, to the owner, occupier, user or responsible party being billed. After 60 days, a door tag shall be hand delivered to terminate water service. On the 67<sup>th</sup> day of non-payment from date of billing, water service will be terminated and not reinstated until all fees, penalties, are paid in full in cash.

The equipment may enhance community preparedness, response, and resiliency while off-setting the costs in a time of fiscal constraints; and

**WHEREAS,** Senate Bill No. 2364 2(a) requires that all local or county law enforcement agencies be approved by resolution by the majority of the full membership of the governing body prior to the transmittal of 1033 Program Application. The DLA requires that applications for program participation be submitted every 365 days; and

**WHEREAS,** the Elmwood Park Mayor and Council (also herein referred to as the "Council" requires that the designated Law Enforcement Support Offices (LESO) Point of Contact for this venue submit a monthly report regarding acquired 1033 Program property to the Chief Executive Official of the venue. In the event that any property had been obtained contrary to the intent of Senate Bill No. 2364 2(a), the State Coordinator shall be contacted and equipment shall be transferred or returned via the federal inventory database system (FEPMIS); and

**WHEREAS,** the Elmwood Park Mayor and Council finds that the Elmwood Park Police Department may request and acquire certain DEMIL B through H (controlled) property in the RTD system without restriction and additional resolutions from the Council. However, it has been determined that based on the Elmwood Park Police Department's needs, it may not acquire armored tactical vehicles, marine vessels over 28 feet, aircraft, weapons, or any items deemed without approval of the governing body. Any special application for weapons, aircraft or MRAP's must be authorized by the Council by resolution prior to the submission of the application/requisition; and

WHEREAS, the Elmwood Park Mayor and Council shall have complete oversight of the Elmwood Park Police Department's participation in the Department of Defense - Defense Logistics Agency - Law Enforcement Support Office/1033 Program and of any and all items obtained from the program; and
