BE IT ORDAINED by the Mayor and Council of the Borough of Elmwood Park, in the County

of Bergen, as follows:

#### **SECTION 1.**

Borough Code Sections 2-32.1 to 2-32.8 ("DEPARTMENT OF PUBLIC WORKS"), be and hereby are repealed and replaced with the following language:

#### § 2-32.1. Creation.

There is hereby created a Department of Public Works, which shall function under the general supervision of the Public Works Department Head of the Borough.

#### § 2-32.2. Appointment of Public Works Department Head and Superintendent.

There shall be appointed by the Mayor and confirmed by the Council, a Public Works Department Head, which shall be an unclassified position pursuant to Civil Service law. There shall also be appointed by the Mayor, upon the recommendation of the Public Works Department Head, and confirmed by the Council, a Superintendent of Public Works. The appointment of the Superintendent of Public Works shall be made in accordance with ratings on a certified list prepared by the State Civil Service Commission after appropriate examination.

#### § 2-32.3. Powers and Duties.

The Public Works Department Head shall have general oversight of the Department of Public Works, and shall report to the Administrator. The Superintendent of Public Works shall report to the Public Works Department Head and shall have general oversight of all subordinate employees in the Department of Public Works. The Department of Public Works shall be responsible for the Borough's public works functions, including but not limited to:

- 1) superintendency of the sewerage and drainage systems of the Borough and repairs thereto;
- 2) flushing the public sewers from time to time to ensure they remain free from all obstructions;
- 3) supervision over all the streets, avenues, roads, public parks and public places of the Borough and all repairs thereto;
- 4) regularly and carefully examining the streets and public sewers and drains;
- 5) ensuring the streets and the public sewers and drains to be properly cleaned and to be kept in good repair;
- 6) removal of all obstructions or encumbrances from any of the streets, avenues, roads, public parks and public places of the Borough and reporting and making complaint of the person or corporation causing any such obstruction or encumbrance to the Judge of the Municipal Court;
- 7) enforcing the provisions of any such obstruction or encumbrance ordinances of the Borough relating to the digging up, obstructing and encumbering of the streets, avenues, roads, public parks and public places of the Borough; and
- 8) carrying out and enforce the provisions of the ordinances of the Borough concerning sewers and other public works functions.

#### SECTION 2. Salary

Ordinance 21-15 entitled "An Ordinance to Fix the Salary, Wage and Compensation of the Officers, Employees and Servants of the Borough of Elmwood Park, County of Bergen, State of New Jersey for the Year 2023", adopted June 15, 2023, be and hereby is amended and supplemented as follows: The chart contained in SECTION II entitled "DEPARTMENT HEAD & NON-UNION EMPLOYEES" be and is hereby amended to reflect the following:

#### SECTION 4. Severability

#### RESOLUTION OF THE BOROUGH OF ELMWOOD PARK, IN THE COUNTY OF BERGEN, NEW JERSEY AUTHORIZING THE PLANNING BOARD TO UNDERTAKE A PRELIMINARY INVESTIGATION TO DETERMINE WHETHER ALL OR A PORTION OF BLOCK 902, LOTS 3 & 4 CONSTITUTE A NON-CONDEMNATION AREA IN NEED OF REDEVELOPMENT PURSUANT TO THE LOCAL REDEVELOPMENT AND HOUSING LAW, *N.J.S.A.* 40A:12A-1 *ET SEQ.*

**WHEREAS**, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.*, as amended and supplemented (the "**Redevelopment Law**"), authorizes municipalities to determine whether certain real property constitute areas in need of redevelopment, and provides a process for those municipalities to participate in the redevelopment and improvement of areas designated by the municipality as areas in need of redevelopment and/or rehabilitation; and

WHEREAS, to determine whether certain parcels of land constitute areas in need of redevelopment under the Redevelopment Law, the Mayor and Council of the Borough of Elmwood Park (the "Borough"), must authorize the Borough planning board (the "Planning Board") to conduct a preliminary investigation of the area and make recommendations to the Mayor and Council; and

WHEREAS, the Mayor and Council believes it is in the best interest of the Borough that an investigation occur with respect to Block 902, Lots 3 & 4 (the "Study Area") to determine whether all or a portion of the Study Area meets the criteria set forth in the Redevelopment Law, specifically, *N.J.S.A.* 40A:12A-5, and should be designated as a non-condemnation area in need of redevelopment without the powers of eminent domain; and

**WHEREAS**, the Mayor and Council therefore authorizes and directs the Planning Board to conduct an investigation of the Study Area to determine whether these parcels meet the criteria set forth in the Redevelopment Law,

**NOW, THEREFORE BE IT RESOLVED** by the Mayor and Council of the Borough of Elmwood Park, in the County of Bergen, New Jersey, as follows:

Section 1. The foregoing recitals are incorporated herein as if set forth in full.

**Section 2.** The Planning Board is hereby authorized and directed to conduct an investigation pursuant to *N.J.S.A.* 40A:12A-6 to determine whether all or a portion of the Study Area satisfies the criteria set forth in *N.J.S.A.* 40A:12A-5 to be designated as a non-condemnation area in need of redevelopment.

**Section 3.** As part of its investigation, the Planning Board shall prepare a map showing the boundaries of the Study Area and the location of the parcels contained therein, and appended thereto shall be a statement setting forth the basis of the investigation.

**Section 4.** The Planning Board shall conduct a public hearing in accordance with the Redevelopment Law, specifically *N.J.S.A.* 40A:12A-6, after giving due notice of (i) the proposed boundaries of the Study Area and stating that a map has been prepared and can be inspected at the Borough clerk's office and (ii) the date of the hearing to any persons who are interested in or would be affected by a determination that the Study Area is a non-condemnation area in need of redevelopment. The notice of the hearing shall specifically state that the redevelopment area determination shall not authorize the Borough or Mayor and Council to exercise the power of eminent domain to acquire any property within the Study Area.

**Section 5.** At the public hearing, the Planning Board shall hear from all persons who are interested in or would be affected by a determination that the Study Area is a non-condemnation area in need of redevelopment. All objections to a determination that the Study Area is a non-condemnation area in need of redevelopment and evidence in support of those objections shall be received and considered by the Planning Board and made part of the public record.

**Section 6.** After conducting its investigation, preparing a map of the Study Area, and conducting a public hearing at which all objections to the designation are received and considered, the Planning Board shall make a recommendation to the Borough Council as to whether it should designate all or some of the Study Area as a non-condemnation area in need of redevelopment.

**Section 7.** The designation of all or some of the Study Area as a non-condemnation area in need of redevelopment, if such designation is made, shall not authorize the Borough to use the power of eminent domain.

Section 8. This Resolution shall take effect immediately.

# **RESOLUTION FOR THE RESCISSION OF PREVIOUSLY APPROVED CANNABIS LICENSES TO OPERATE WITHIN THE BOROUGH OF ELMWOOD PARK**

**WHEREAS**, on February 22, 2021, Governor Murphy signed into law PL. 2021, c.16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of cannabis by adults twenty-one (21) years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and,

**WHEREAS**, the Act establishes six (6) marketplace classes of licensed cannabis businesses, specifically including a Micro-Business Cannabis License for locations at which cannabis items and related supplies are sold to consumers; and

**WHEREAS**, the Borough's Ordinance created a Cannabis Administrative Board (the "Board") to act as the local Agency to process and administer the licensing procedures for the Borough and to make recommendations regarding same for submission to the Borough Council; and

**WHEREAS,** Essential Cannabis Corp., NJ Patients Care LLC and Treehouse Dispensary LLC (the Applicant's) have completed and submitted the required application and documentation to the Borough of Elmwood Park Cannabis Administrative Board required pursuant to Ordinance No.: 21-13; and

#### **RESOLUTION OF THE APPROVAL FOR MIDLAND BUD HOUSE LLC TO RECEIVE A MICRO-BUSINESS CANNABIS LICENSE TO OPERATE AT 21 MIDLAND AVENUE, WITHIN THE BOROUGH OF ELMWOOD PARK**

**WHEREAS**, on February 22, 2021, Governor Murphy signed into law PL. 2021, c. 16, known as the "New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act" (the "Act"), which legalizes the recreational use of cannabis by adults twenty-one (21) years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and,

**WHEREAS**, the Act establishes six (6) marketplace classes of licensed cannabis businesses, specifically including a Micro-Business Cannabis License for locations at which cannabis items and related supplies are sold to consumers; and,

**WHEREAS**, Section 31a of the Act authorizes municipalities to adopt by ordinance the number of the Micro-Business Cannabis Licenses that will be available in a municipality; and,

**WHEREAS**, the Borough Council of the Borough of Elmwood Park adopted an Ordinance which established that three (3) Micro-Business Cannabis Licenses would be available for a cannabis establishment to operate within the Borough (the "Ordinance"); and

**WHEREAS**, the Borough's Ordinance created a Cannabis Administrative Board (the "Board") to act as the local Agency to process and administer the licensing procedures for the Borough and to make recommendations regarding same for submission to the Borough Council; and

**WHEREAS**, the Ordinance further established that the Cannabis Retail licensee be required to site his, her or its establishment within a designated area of the Borough known as the Cannabis Overlay Zone; and;

**WHEREAS**, Midland Bud House LLC, completed and submitted the required application and documentation to the Borough of Elmwood Park Cannabis Administrative Board required pursuant to Ordinance No.: 2113, Section 4-7.3(D)(1) for a retail micro-business license; and

**WHEREAS**, after careful review of the application, documentations submitted and a meeting with Midland Bud House LLC, the Borough of Elmwood Park's Cannabis Administrative Board recommends, by way of attached resolution, to the Mayor and Council the issuance of one (1) Micro-Business Cannabis License to Midland Bud House LLC.

**NOW, THEREFORE BE IT RESOLVED**, by the Mayor and Council of the Borough of Elmwood Park, that pursuant to the recommendation of the Elmwood Park Cannabis and Cannabis Administrative Board of the Borough of Elmwood Park, as follows:

1. The Mayor and Council hereby, after consideration of the recommendation made by the Elmwood Park Cannabis and Cannabis Administrative Board to approve the issuance to Midland Bud House LLC of one of its Micro-Business Cannabis Licenses based on satisfying the Board's approval and the requirements ordinance.

2. The Borough Zoning Official has confirmed that Midland Bud House LLC's location at 21 Midland Avenue is located in the C-G Zone, which is suitable for cannabis retailers.

3. The issuance of a license to the license applicant by the Commission would not exceed the limit of such licenses as authorized by the Ordinance. Nothing in this Resolution shall preclude the Mayor and Council from issuing additional resolutions of municipal support to other applicants, to the extent that may be permissible under the regulations promulgated by the Cannabis Regulatory Commission, nor shall it limit the Mayor and Council's authority with respect to any request for input from the Cannabis Regulatory Commission as to their preferred licensee should more applicants seek licenses within the Borough than are available under the Ordinance. Nothing in this Resolution is intended to affirm that Midland Bud House LLC will ultimately be granted a license from the Borough of Elmwood Park to operate a cannabis business within the Borough as evidence of compliance with the Borough's laws and regulations will be required to be demonstrated by the applicant at the appropriate time.
